## BUFFALO HIGHLANDS METROPOLITAN DISTRICT NO. 1 2025 BUDGET SUMMARY OF SIGNIFICANT ASSUMPTIONS

Disclosures contained in this summary as presented by management, are those that are believed to be significant as of the date of the compilation report and are not intended to be all-inclusive. The disclosures are intended to describe assumptions used during the preparation of the 2025 annual budget. Actual results may differ from the prospective results contained in the budget.

#### SERVICES PROVIDED

The Buffalo Highlands Metropolitan District No. 1 (District) was organized in 2023 along with Buffalo Highlands Metropolitan District No. 2 (District No. 2) and Buffalo Highlands Metropolitan District No. 3 (District No. 3). All of the Districts combined are referred to as the Districts. The Districts were organized in Weld County, Colorado and are governed pursuant to provisions of the Colorado Special District Act. The Districts were organized to provide for the planning, design, acquisition, construction, installation, and financing of public improvements as authorized by intergovernmental agreements with the Town of Mead (Town).

The District is authorized to provide services related to mosquito control, parks and recreation, safety protection, street landscaping, television relay and translation, covenant enforcement and design review, and transportation. The District shall only operate and maintain public improvements that are not accepted for ownership, operations and maintenance by the Town or other appropriate entity.

The District obtained voter approval to retain and spend any excess revenues collected under Article X, Section 20 of the Colorado Constitution.

The District prepares its budget on the modified accrual basis of accounting.

The District has no employees and all operations and administrative functions are contracted. The District is governed by an elected Board of Directors.

### REVENUE/EXPENDITURES

Developer Advances

The District is anticipating developer advances to fund operating costs of the District.

#### RESERVES

The District is not anticipating any revenue that is subject to TABOR. Therefore, no emergency reserve is required.
